• What is mifepristone?

Mifepristone is one of two medications most commonly used in medication abortion in the United States. Mifepristone is safe, effective, and has been used by more than 5 million people in the U.S. since the FDA approved it more than 20 years ago.

Is mifepristone safe?

■ There is overwhelming evidence that medication abortion using mifepristone is safe and effective for virtually anyone who wants to end an early pregnancy, with a safety record of over 99%

Questions about the court case

 A group of anti-abortion activists and organizations sued the FDA over its approval of mifepristone, one of two medications most commonly used in medication abortion in the United States. The plaintiffs asked the court to order the FDA to rescind its approval of mifepristone from more than 20 years ago, in order to remove it from the market.

What does this mean for Planned Parenthood?

 PP health centers across the country will continue to do whatever is possible to provide patients with timely abortion care, including the method that is best for their circumstances, within the bounds of the law.

TRICKY Q&A re: Margaret Sanger & PP

Black and Brown Planned Parenthood staff have come forward to talk about how they were poorly treated at Planned Parenthood. How are you claiming to have reckoned with your past if your own staff complain of discrimination and unfair treatment?

Over the years, staff at PPFA and Planned Parenthood affiliates have spoken out when they see discrimination and challenging work environments for people of color, especially Black staff. Planned Parenthood's skilled and dedicated staff are at the core of who we are, and we are standing with them when they point out conduct that runs afoul of our mission and values.

We take this seriously. We are investing in creating belonging and equity through our health care delivery, our advocacy, our education, <u>and</u> our staff engagement. Examining our

relationship with Margaret Sanger and our organization's origins — and using that insight to rectify our past — is a step toward doing better for all of our staff, patients, and volunteers. We are committed to equity within our offices and at Planned Parenthood health centers.

You're admitting that Margaret Sanger was a racist. Isn't this proof that Planned Parenthood was founded by someone who wanted to exterminate Black people?

No. There is no evidence that Margaret Sanger wanted to exterminate Black people, or supported "Black genocide." However, Margaret Sanger, who founded the organization that became Planned Parenthood, believed in eugenics — an ideology that labeled certain people unfit to have children. Although at times Sanger argued for a eugenics that was not based on race or religion, eugenics is inherently racist and ableist. Planned Parenthood denounces Margaret Sanger's belief in eugenics and condemns the irreparable damage these beliefs caused to the health and lives of countless people. While Sanger's work with the Black community was deeply flawed and harmful, there is no evidence her work ever intended to exterminate any race.

Planned Parenthood believes that all people — of every race, religion, gender identity, ability, immigration status, and geography — are full human beings with the right to determine their own future and decide, without coercion or judgement, whether and when to have children. Margaret Sanger's racism and belief in eugenics are in direct opposition to our mission and values.

Does Planned Parenthood target Black and Latino neighborhoods with abortion clinics?

No, this is false; it's insulting and degrading. Black and Latino/a/x leaders in Planned Parenthood and Reproductive Justice organizations will tell you: It's time we allow all people — including Black and Latino/a/x people — the autonomy to make their own health care decisions. There is a long and ugly history of this country taking away the rights of people of color. That includes the right to decide whether and when to have children.

After years of making excuses for Margaret Sanger, why are you suddenly choosing to acknowledge that Margaret Sanger was racist now?

By openly discussing, addressing, and resolving our historical shortcomings, we hope to make our own organization an example of belonging, equity, and respect within the health care system. Whereas in the past, we have attempted to soften the harm caused by Sanger's legacy by highlighting the positive effects of the reproductive freedom movement, we realize that we

must be unequivocal in our denouncement of her beliefs and the damage it caused to generations of people.

The last year — as COVID-19 devastates communities, and the country reckons with our racist history and present — has made it more clear than ever that racism is a threat to the health, safety, and well-being of Black, Latino/a/x, Asian American and Pacific Islander, and Indigenous people. As a country, we must continuously question ourselves, our structures, and our processes to identify areas where improvement and progress are needed. Only after confronting this, will we improve health equity.

Planned Parenthood has been accused of "stepping on the toes" of Black-led Reproductive Justice organizations. Given this pattern, along with your acknowledgement that Planned Parenthood's founder was racist, why should RJ leaders and organizations — and other Black women — trust you?

Until recently, Planned Parenthood had kept quiet during times when we should have spoken out more assertively against racism, discrimination, and white supremacy, and took up too much space in moments where fellow leaders' and partners' voices should have been elevated. This includes the efforts of our Reproductive Justice partners.

These past missteps were opportunities to learn and grow, and we are committed to being good partners in the movement towards reproductive freedom for all people. That means stepping up to use our voice, resources, and expertise to help ensure all people have the right to determine their own future, and stepping back into a supportive role when other organizations are leading the charge.

Planned Parenthood wouldn't exist if it weren't for Sanger. Why are you cancelling her?

Planned Parenthood isn't "cancelling" Margaret Sanger. We are acknowledging the full scope of her legacy and the harm she caused with her embrace of eugenics — an inherently racist and ableist ideology that is in direct opposition to Planned Parenthood's values and beliefs. We need to acknowledge and learn from our own history so that we can continue to do better for our patients, supporters, and future generations.

Why aren't you also talking about all the incredible things Margaret Sanger did for generations of women?

For more than a century, Planned Parenthood had celebrated Margaret Sanger and her legacy, without denouncing the eugenic beliefs she held and the way those beliefs harmed generations

of disabled people and people of color. We must acknowledge how silence carried on that legacy . This acknowledgment does not erase how elements of the movement for reproductive freedom improved the lives of many women by giving them control of their bodies and lives. Both legacies are true.

Margaret Sanger started the "Negro Project." Doesn't that prove she wasn't racist?

Margaret Sanger believed in eugenics, an inherently racist and ableist ideology. Sanger began what was called the "Negro Project" in 1939 along with Black leaders like W.E.B. DuBois and Mary McLeod Bethune. The goal of this project was to increase birth control access in Black communities in the South by staffing birth control clinics with Black doctors and nurses. Sanger lost control of this project, and under the leadership of white men, Black women were instead sent to white doctors for birth control services, which heightened issues of paternalism and racism in health care.

Q: How can I become involved as a clinic escort?

A: We encourage you to check your local Planned Parenthood to see if they have any opportunities. You may not receive a response from them right away because many are overwhelmed with lots of volunteers right now! Spot On has a feature that allows you to anonymously use the app and track. We are also considering a future release to enhance our security measures. In the meantime, you can log out when you're done tracking! Hope this helps!

Will Planned Parenthood's Spot On app sell my data? Especially if I'm in a state with restrictions in place?	Hi there. Thank you for your question. Spot On never sells user data. We collect the minimal amount of data required to provide the tool, while rigorously safeguarding the privacy of our users by ensuring the proper data protections are in place. We only receive anonymized aggregated data, which is used to gather insights and identify trends to improve the product. This is only shared within our team, or specific third-party platforms — such as an analytics service — which have been vetted by our Information Security team. Additionally, Spot On does not share data with other health providers, health plans, or clearing houses, so it is not subject to Health Insurance Portability and Accountability Act (HIPAA) laws as well.

What does the SCOTUS decision mean?	 The Supreme Court's decision confirms our deepest fears. The court has taken away the constitutional right to abortion, and overturned Roe v. Wade. The decision is as dangerous as it is shocking, and will open the floodgates for states across the country to ban abortion. This is not the end goal for the anti-abortion movement. Their ultimate goal is to pass a nationwide abortion ban that would block abortion access in every state in the country. Is <i>Roe v. Wade</i> overturned?	 Yes, the Supreme Court has overturned <i>Roe v. Wade</i>, ending the federal constitutional right to abortion For now, abortion is still legal in the majority of the country. However, we will soon see states' trigger laws and other bans go into effect, and other states' legislatures will move to ban abortion. Planned Parenthood is committed to getting people the resources and information they need to access an abortion, no matter where they live.

I want to host/transport patients	It is incredibly generous to open your home to provide support for patients who will be forced to travel to access abortion. While we do not coordinate these efforts at the national office, I encourage you to reach out to both your local Planned Parenthood affiliate and local abortion fund — the primary point of contact for patients — and supporting their logistical and financial needs in your area.
